PERMITS WILL BE ISSUED SUBJECT TO THE FOLLOWING CONDITIONS:

- 1) All work to be done in accordance with provisions of the Town of Tyngsborough Street Opening By-Laws.
- 2) Compliance with Massachusetts General Laws, Chapter 82, Section 40.
- 3) The Superintendent of Streets or Designee, Chief of Police, Chief of Fire Department, Water Department and Sewer Department must be notified **48 hours prior to excavation start, and also on the day prior to resurfacing of opening.**
- 4) Emergency street openings will be authorized by the Superintendent of Streets or Designee. The Chief of Police is to be notified of Emergency street openings.
- 5) Superintendent of Streets or Designee must be notified upon **completion of work** to enable final inspection procedures check.
- 6) The provisions of the permit may be changed to meet existing conditions where Public Safety and convenience require it in the opinion of the Highway Department Superintendent or Designee.
- 7) The permittee will be responsible for securing a Police Detail.
