CONSUMER NOTIFICATION**

The Town of Tyngsborough is pleased to announce that **First Point Power** ("First Point") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). First Point will provide electric power supply for all consumers participating in Tyngsborough's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will continue to see First Point printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

PARTICIPATING CONSUMERS will start benefiting from the aggregation rate beginning on the day of the month in November 2019 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION you do not need to take any action to participate. You will automatically be enrolled. If you do not wish to participate, please follow the instructions specified.

IF YOU WISH TO JOIN THIS PROGRAM you may OPT-IN at www.colonialpowergroup.com/tyngsborough/ OR call First Point at (888) 875-1711 and ask to be enrolled.

IF YOU DO NOT WISH TO PARTICIPATE you must OPT-OUT at www.colonialpowergroup.com/tyngsborough/, click the OPT-OUT button and follow the instructions specified OR call First Point at (888) 875-1711.

TO CHOOSE A GREENER PRODUCT WITH A HIGHER PERCENTAGE OF RENEWABLE ENERGY you may call First Point at (888) 875-1711 and ask to be enrolled in Tyngsborough's Optional Green Product. Tyngsborough's Optional Green Product provides 100% National Wind Renewable Energy Certificates (RECs). This product is being offered at \$0.10733 per kWh for 24 months (November 2019 to November 2021).

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against National Grid Basic Service. However, such savings and future savings cannot be guaranteed.
